Please accept this letter as notification that Elekta Inc. will acquire Nucletron Corporation on or about March 1, 2012. At that time, control of the licensing activities will be transferred to Elekta Inc. but will remain doing business as Nucletron Corporation as to avoid any interruption in servicing activities. Nucletron Corporation is requesting the Department's written consent for the transfer and also requests an amendment to the above referenced license to reflect the name change; the business address remains the same. The new business name will be:

2. *Describe any changes in personnel or duties that relate to the licensed program. Include training and experience for new personnel...*

There are no changes in personnel or duties that relate to the licensed program. All former Nucletron trained service engineers will continue to perform their respective duties as previously established. These engineers will become Elekta Inc. employees as of March 1, 2012. Debra Bensen will remain as RSO for the licensed program.

3. *Describe any changes in the organization, location, facilities, equipment or procedures that relate to the licensed program...*

Besides the change in business name, there are no changes in the organization, location, facilities, equipment or procedures that relate to the licensed program.

4. *Describe the status of the surveillance program (surveys, wipe tests, quality control) at the present time and the expected status at the time that control is to be transferred...*

Nucletron Corporation processes and procedures have been accepted and licensed by MDE (License #MD-27-035-01). No licensed radioactive material is maintained at the Nucletron Corporation facility. Ir-192 sealed sources are shipped directly to the medical facility where the Nucletron trained service engineers conducted the surveys, wipe tests and QC. All facility records are currently maintained at Nucletron Corporation. Once control is transferred all established processes and procedures will continue to be maintained as previously accepted.

5. *Confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to the transferee or to the Department, as appropriate. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity...*

N/A No licensed material is kept at the Nucletron Corporation facility therefore decommissioning of the facility is not necessary.

6. *Confirm that the transferee will abide by all constraints, conditions, requirements and commitments of the transferor or that the transferee will submit a complete description of the proposed license program...*
