Dear Ms. Park:

In conjunction with the letter dated January 30, 2012 notifying the MDE of the business acquisition on or about March 1, 2012, the description of the transaction required for the change in control is described below.

1. *Provide a complete description of the transaction (transfer of stocks or assets, or merger).*

To keep the regulatory licenses in effect, Elekta Inc. must register to do business in Maryland as "Elekta, Inc. dba Nucletron Corporation." This needs to occur in a two-step process which results in a gap of 2 - 3 days between the merger date and the date that we can register to do business in Maryland. The steps are outlined as follows:

Step #1 - Parent company of Nucletron Corp. will file an "Articles of Merger" to Elekta Inc. on March 1. This takes about 2 - 3 business days resulting in potential process completion around March 5 or 6 (includes a Saturday and Sunday non-business days). Step #1 needed prior to Step #2.

Step #2 - Elekta Inc. will file a trade name registration for Nucletron Corporation in Maryland upon receipt of the merger for Nucletron Corp into Elekta Inc. (Step #1).

Based on the above timeline, we need to verify that there is not a problem in service/source activities from March 1 - 6 (estimated end date) while the merger is being processed. Please review our plans for registration (2 steps) and confirm whether there are any negative issues during the Step #1 processing. We will make any company modifications based on your response.
