AMENDMENT OF THE DESCRIPTION OF THE FACILITY ENDORSEMENT


It is agreed that Item 3 of the Declarations as stated in Endorsement No. 1 is further amended to read:



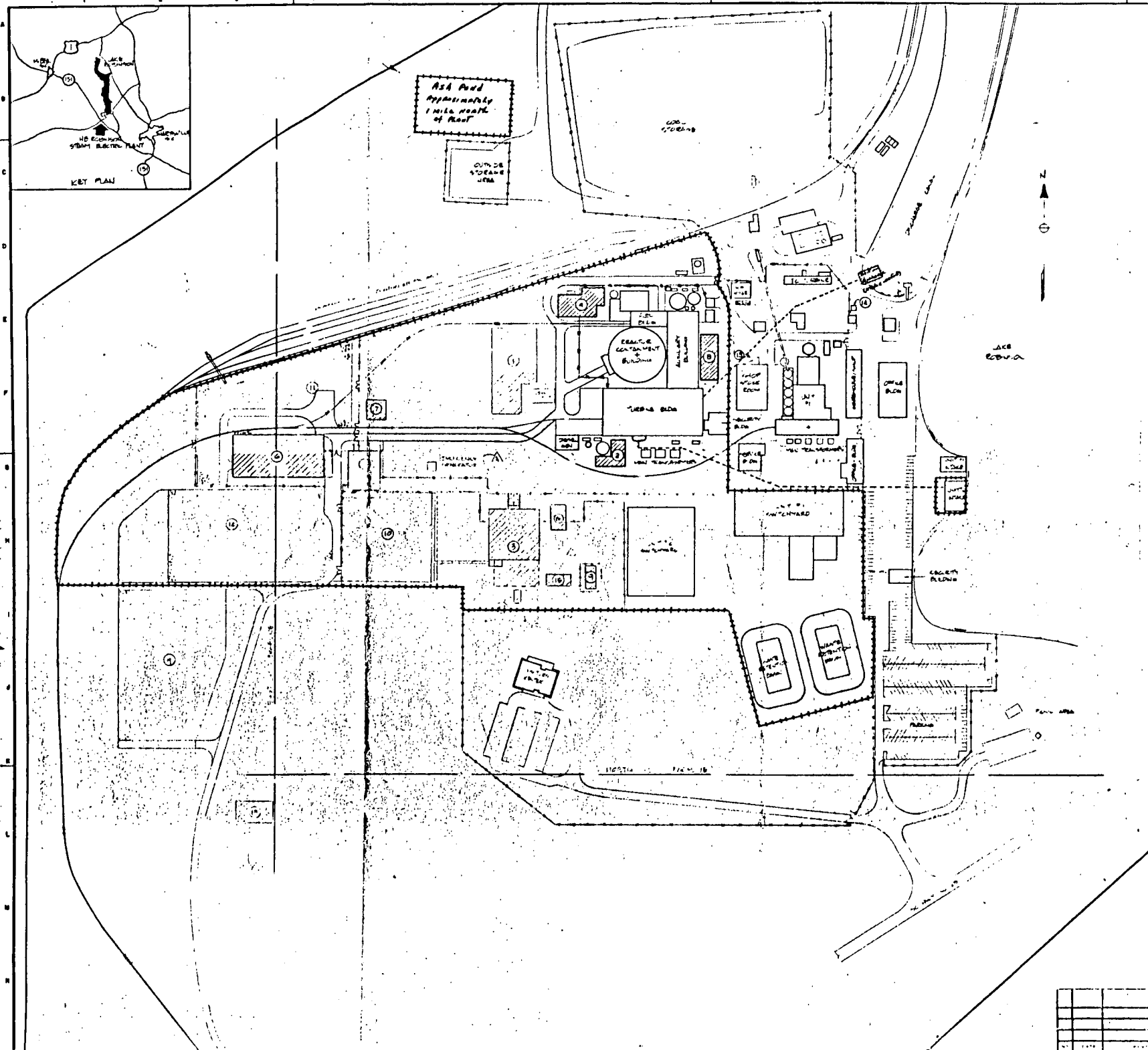
