Gentlemen:

Pursuant to 10CFR50.54(w)(4), Carolina Power & Light Company (CP&L) hereby submits information regarding the present level and source of on-site property damage insurance.

CP&L has in full force and effect at the H. B. Robinson Steam Electric Plant, Unit No. 2 (HBR2), the Brunswick Steam Electric Plant, Unit Nos. 1 and 2 (BSEP), and the Shearon Harris Nuclear Power Plant (SHNPP), primary nuclear property insurance in the amount of \$500,000,000 with Nuclear Mutual Limited which expires April 1, 1989. This coverage is being renewed effective April 1, 1989 for the period April 1, 1989 to April 1, 1990.

CP&L also has in full force and effect at HBR2, BSEP, and SHNPP, excess nuclear property insurance in the amount of \$825,000,000 with Nuclear Electric Insurance Limited covering the period November 15, 1988 to November 15, 1989.
