REQUEST FOR MINOR CHANGE TO AN APPROVED EXEMPTION

Gentlemen:

The purpose of this letter is to request a minor change to the exemption from the requirements of 10CFR50, Appendix E Section F.2 for the H. B. Robinson Steam Electric Plant, Unit No. 2 (HBR2) approved by NRC letter dated December 30, 1993. The exemption was a schedular exemption which allowed performance of the onsite portion of the required annual Emergency Preparedness exercise to be delayed from November 30, 1993, until the week of March 21, 1994.

Carolina Power & Light (CP&L) Company requests that the approved exemption be amended to allow the exercise to be conducted March 30, 1994. The tentative schedule for the exercise to be held during the week of March 21, 1994, has proven to be undesirable since CP&L has learned that an exercise during that week would conflict with scheduled training being conducted by the affected State agencies. Additionally, deferral of Licensed Operator Requalification training and examinations, due to an extended forced outage, has resulted in the plant simulator being unavailable to support the exercise during the week of March 21, 1994.

The justifications cited in the exemption request submitted on November 21, 1993, and supplemented on November 22, 1993, remain valid. This request for a schedular change to the approved exemption does not alter the environmental assessment and finding of no significant impact issued by the NRC on December 28, 1993, since the change involves an extension of only three calendar days.
