REVISED RESPONSE TO SUPPLEMENT 1 TO GENERIC LETTER 87-02

Gentlemen:

The purpose of this letter is to revise our committed submittal date for the results of the implementation of the resolution of Unresolved Safety Issue (USI) A-46, "Verification of Seismic Adequacy of Mechanical and Electrical Equipment in Operating Reactors," for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2.

Carolina Power & Light Company's response, dated September 19, 1992, to Supplement 1 to Generic Letter 87-02 provided an initial submittal date of 120 days after Refueling Outage 15 for the USI A-46 summary report. This was subsequently revised to December 31, 1994, by letter dated October 15, 1992. Evaluations are nearing completion; however, due to the interrelationship between the USI A-46 results and the seismic portion of the Individual Plant Examination of External Events (IPEEE), we are revising our submittal date for the USI A-46 summary report to coincide with the submittal of the IPEEE results, currently scheduled for June 30, 1995.
