Gentlemen:

By letter dated March 28, 1997, the NRC requested that Carolina Power & Light (CP&L) Company submit a revised Quality Assurance (QA) Program that contained the Current Technical Specifications (CTS) requirements that are to be relocated to the QA Program. The NRC requested that the revised QA Program be submitted to allow NRC review prior to issuance of the NRC Safety Evaluation Report (SER) for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2 Improved Technical Specifications (ITS).

Accordingly, an approved revision to Updated Final Safety Analysis Report (UFSAR) Section 17.3, Appendix A, "RNP Quality Assurance Program Description," is provided as an attachment. The attached information is an approved change to the UFSAR that will be included in the next scheduled revision to the UFSAR scheduled in accordance with 10 CFR 50.71(e).

Since the relocated requirements are duplicated in the CTS, the inclusion of these requirements in the QA Program description does not represent a reduction in commitment as defined in 10 CFR 50.54a. The relocation of these requirements has been reviewed against the criteria of 10 CFR 50.59 and has been found not to involve an unreviewed safety question.
