ADDITIONAL INFORMATION ON AUXILIARY FEEDWATER MODIFICATIONS

Dear Mr. Schwencer:

On December 10, 1979, your staff telecopied to Carolina Power & Light Company (CP&L) a request for additional information on Short Term Lessons Learned items 2.1.7.a and 2.1.7.b dealing with Auxiliary Feedwater initiation and flow indication. You followed this action with the formal transmittal of a letter dated December 12, 1979 (received by CP&L December 17) requesting the same information and requesting a response by December 14, 1979. Based on agreements made during telephone conversations with members of the Bulletins and Orders Task Force (D. F. Ross and T. Novack) on December 12, CP&L will supply the requested information by December 31, 1979. As explained to Mr. Ross and Mr. Novack, to provide the information any sooner would seriously dilute our efforts to complete the required modifications. The agreed upon date will allow CP&L to concentrate its resources on completing required modifications while providing information to the NRC in a timely manner.
