Dear Mr. Varga:

By letter dated October 25 and as supplemented March 5, 1984, Carolina Power & Light Company (CP&L) submitted a request for temporary exemption from the requirements of 10 CFR 73.55 during the H. B. Robinson Steam Electric Plant Unit No. 2 steam generator repair outage. On April 3, 1984, NRC informed CP&L that these letters and any subsequent submittals are required to be signed under oath, as they are considered to be an application for a license amendment.

In response to your April 3, 1984 letter, CP&L hereby resubmits its October 25, 1983 and March 5, 1984 letters, signed under oath as required. The attachments referred to in the letters forwarded herewith were intentionally deleted from this submittal. These attachments contained Safeguards Information, which has not changed, and were included in our original letters noted above. To ensure that confusion regarding submittal sequence does not result, the attached letters will retain their original submittal date, but are signed under oath by Mr. A. B. Cutter, Vice President, Carolina Power & Light Company.
