ORGANIZATIONAL CHANGES

Gentlemen:

Carolina Power & Light Company (CP&L) has announced the following organizational changes in its Nuclear Generation Group. Effective August 13, 1990, Mr. Alan B. Cutter has become Vice President, Director of Special Nuclear Projects and will continue to report to Mr. R. A. Watson, Senior Vice President - Nuclear Generation. In this position, Mr. Cutter will provide strategic support to nuclear management concerning external nuclear industry activities. Also effective August 13, 1990, Mr. Gerald E. Vaughn joined CP&L as Manager of the Nuclear Services Department, reporting to Mr. Watson. Mr. Vaughn has extensive experience in nuclear operations management and has served as Vice President of Nuclear Operations for Houston Lighting and Power's South Texas Project, and as General Manager of Nuclear Stations for Duke Power Company. On September 19, 1990, Mr. Vaughn was elected Vice President - Nuclear Services Department. Also effective September 19, 1990, Mr. R. B. Richey, Manager of the Harris Nuclear Project, was elected Vice President - Harris Nuclear Project.

On September 4, 1990, Mr. Kenneth R. Karr joined CP&L as Assistant to Mr. R. A. Watson on an 18-month assignment as a loaned executive from the Institute of Nuclear Power Operations (INPO). Mr. Karr has 25 years service in the U. S. Nuclear Navy Program and principally served as the lead in a number of plant evaluation teams at INPO.
