WITHDRAWAL OF REQUEST TO USE AN ALTERNATIVE TO 10CFR50.55a REQUIREMENTS

Gentlemen:

The purpose of this letter is to request withdrawal of Carolina Power & Light Company's (CP&L) request, dated December 20, 1991, to use an alternative to the current requirements of 10CFR50.55a at the H. B. Robinson Steam Electric Plant, Unit No. 2 (HBR2).

The specific request would authorize CP&L to use subsections IWA-4500 and IWA-4510 in the 1990 Addenda to the ASME Code, Section XI to develop weld procedure specifications for potential repairs to material fabrication flaws in the steam generator girth welds at HBR2. The provisions of 10CFR50.55a(b)(2) currently approve the use of the 1986 Edition (no Addenda), and previous Editions, for ASME Code, Section XI.

Reinspections of the steam generator girth welds during Refueling Outage 14 have shown that the alternative is not currently needed; therefore, CP&L requests withdrawal of the December 20, 1991 request.
