

Carolina Power & Light Company (CP&L) hereby submits the Final Summary Report (FSR) and a proposed implementation schedule for the H. B. Robinson Steam Electric Plant, Unit No. 2 (HBR2) Detailed Control Room Design Review (DCRDR). The DCRDR FSR is being submitted within the time frame stated in CP&L Letter NLS-84-509, "Response to Order Confirming Commitments on Emergency Response Capability", dated December 31, 1984.

The attached DCRDR FSR provides the information required by NUREG-0737 Supplement 1 for the staff to complete its review of the HBR2 DCRDR program. In addition, the FSR incorporates that material discussed with the NRC and SAI reviewers during the September 12, 1985 DCRDR meeting regarding both HBR2 and the Brunswick Steam Electric Plant.


