Carolina Power & Light Company (CP&L) has received letters from the Office of Investigations dated May 22, 1989 (attached) requesting information concerning procurement of electrical components and/or parts from Planned Maintenance Systems, Inc. (PMS) of Mount Vernon, Illinois during the period of July 1, 1985 to the present. Our subsequent review of procurement records indicates that CP&L has not purchased such items from PMS during this period for the Brunswick Steam Electric Plant, Unit Nos. 1 and 2, the H. B. Robinson Steam Electric Plant, Unit No. 2, and the Shearon Harris Nuclear Power Plant.
