On June 29, 1979 the NRC issued Amendment No. 39 to the operating license for H. B. Robinson Unit 2, authorizing operation at 2300 MWt. We appreciate your issuance of the amendment promptly after the Atomic Safety & Licensing Board's June 26 Order, since this enabled CP&L to complete plant modifications required for 2300 MWt operation during the recent maintenance outage rather than scheduling the work for a future outage.
