

REQUEST FOR TECHNICAL SPECIFICATION CHANGE

REQUEST FOR LICENSE AMENDMENT - PRIMARY COOLANT ISOLATION VALVES

Dear Mr. Varga:

In accordance with the Code of Federal Regulations Title 10, Section 50.90 and Section 2.101, Carolina Power & Light Company (CP&L) submits the attached changes to the H. B. Robinson Unit No. 2 Technical Specifications. These changes, which were discussed with your staff by telephone on May 4, 1981, incorporate administrative changes to the technical specifications issued as Attachment 3 to Mr. Darrell G. Eisenhower's Order of April 20, 1981. The changes incorporate surveillance requirements that reflect plant configuration and parallel valve testing capability, as well as several typographical error corrections.

Because of the steam generator inspection outage which is scheduled to begin between May 15 and May 29, 1981, it is requested that these technical specifications be processed on an expedited basis, such that a license amendment is issued prior to May 15, 1981, should the outage begin then.

Enclosed are the replacement pages of H. B. Robinson Steam Electric Plant, Unit No. 2 Technical Specifications which reflect these revisions. Appropriate changes are indicated by the vertical line in the margin of the affected pages.

In accordance with 10CFR170.12(c), we have determined that this revision constitutes a Class II Amendment. Accordingly, our check for \$1,200 is enclosed.
