PARTIAL WITHDRAWAL OF ORGANIZATIONAL LICENSE AMENDMENT REQUEST

Gentlemen:

The purpose of this letter is to request partial withdrawal of the license amendment request for the H. B. Robinson Steam Electric Plant, Unit No. 2 concerning Nuclear Assessment Department and plant site organizational and administrative changes submitted on January 15, 1991.

One part of the package was a request to change the title of the Robinson Nuclear Project Department Head from "Vice President - Robinson Nuclear Project" to "Department Head - Robinson Nuclear Project." Feedback from the NRC staff indicated that the NRC must have the specific title as previously provided in the Technical Specifications. Since the submittal of this change request, Mr. C. R. Dietz has been promoted to Vice President. Thus, the existing title in the Technical Specifications is now correct. Accordingly, Carolina Power & Light Company requests withdrawal of this portion of the change.

Retyped pages reflecting the withdrawal are enclosed. These pages replace corresponding pages in the January 15, 1991 submittal.

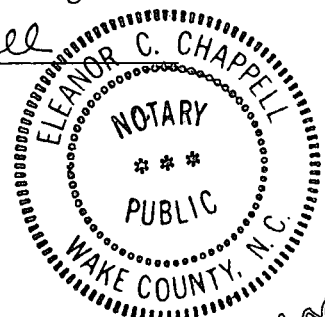
