Dear Mr. Varga:

Carolina Power & Light Company (CP&L) has assessed our existing and planned facility procedures and training programs with respect to the matters described in NRC Generic Letter 81-04 concerning Emergency Procedures and Training for Station Blackout Events. We have determined we will be complete with the actions described in items (c), (d), and (f) of your letter by August 25, 1981.

With respect to items (a), (b), (e), and (g) of your letter, the Westinghouse Owners Group has informed you in letter OG-56 from R. W. Jurgensen, Chairman to D. G. Eisenhut, NRC dated April 9, 1981, of their intention to submit guidelines concerning these items to the NRC by September 1, 1981. This letter also advised you that the Westinghouse Owners Group intends to provide a detailed discussion of the developed guidelines with member utilities approximately October 1, 1981. Accordingly, CP&L will complete items (a), (b), (e), and (g) subsequent to the development of these guidelines by the Westinghouse Owners Group.
