

Dear Mr. Denton:

On March 11, 1981, CP&L filed a request for exemption from Section III.0, 10CFR50, Appendix R, concerning the reactor coolant pump lube oil collection system. Subsequent discussion with your staff led to requests for additional information. During the ensuing time period, discussions between the NRC staff and industry have led to clarifications of the type of information required for an exemption submittal. Accordingly, we plan to file additional information concerning this exemption request. In order to consolidate your staff's review of the HBR Fire Protection Program, we will file this information on April 27, at the same time we file our justification for the four additional exemption requests identified in our March 16, 1982 submittal.
