SUBJECT: SUMMARY OF JULY 22-24, 2014, PUBLIC AND CLOSED
MEETINGS WITH THE U.S. NUCLEAR REGULATORY
COMMISSION STAFF AND NUSCALE POWER™, LLC, TO
DISCUSS NUSCALE'S TESTING PROGRAMS AND ASME
PIPING CODES (TAC No. RN6110)

On July 22-24, 2014, the staff from the U.S. Nuclear Regulatory Commission (NRC) and representatives from NuScale Power, LLC (NuScale) held a three-day meeting at the NRC headquarters, located at Two White Flint North, 11545 Rockville Pike, Rockville, MD 20852. On July 22nd, a meeting was held with NuScale personnel for NuScale to make a public presentation to the NRC staff on: the NuScale plant design overview; NuScale Integral System Tests at the NuScale Test Facility; Comprehensive Flow Induced Vibration (FIV) Assessment Program for Reactor Vessel Internals; In-service Inspection/Testing (ISI/IST); Appendix J Testing; and ASME Piping Design. NuScale also provided an update on the NuScale Testing Program. The later half of the meeting was closed to discuss proprietary information related to the NuScale Test Facility and Testing Program.

On July 23rd and July 24th, NuScale personnel covered all the topics that they had discussed on July 22, in much greater technical detail, which included proprietary information. On July 23rd, NuScale representatives discussed their Comprehensive FIV Assessment Program Plan, including prototype and plant start-up testing. NuScale also discussed screening methodology to select those components, including steam generators, most susceptible to FIV; various FIV mechanisms, and post-operation inspections. Additionally, NuScale staff described their activities and plans regarding use of Regulatory Guide 1.20, Rev. 3, "Comprehensive Vibration Assessment Program for Reactor Internals During Preoperational and Initial Startup Testing" to address NRC requirements.

On July 24th, NuScale staff gave a presentation to the NRC staff on their approach to addressing ISI/IST regarding reactor vessel internals and their plans for satisfying the requirements to determine containment leakage rate as set forth in Appendix J to 10 CFR Part 50, "Primary Reactor Containment Leakage Testing for Water-Cooled Power Reactors".

Meetings and presentations held on July 22 (second half of meeting) and on July 23-24 were closed to the public because NuScale discussed proprietary information regarding the design of their small modular reactor (SMR).
