

PRESSURIZER SAFETY VALVE NOZZLES



In our letter of July 6, 1971, to Dr. Peter A. Morris we stated that we would perform a liquid penetrant inspection of the pressurizer safety valve nozzles during our first refueling outage. This inspection was to check for possible sensitization of the type 316 stainless steel nozzle due to the hard surfacing operation during manufacture. Visual and liquid penetrant inspections were performed during our recent first refueling outage. No indication of sensitization was found, and the valves were returned to service. Normal inservice inspection will continue to be performed on these valves in accordance with ASME-Section XI, Inservice Inspection of Nuclear Reactor Coolant Systems.

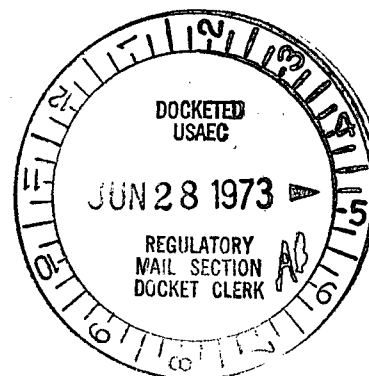
