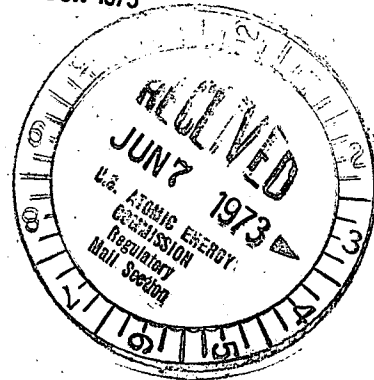

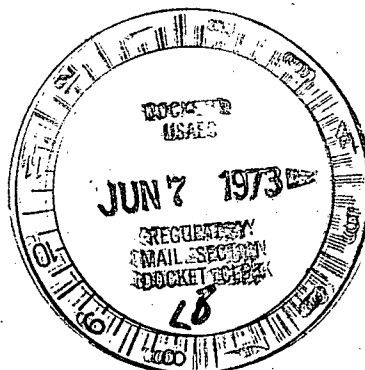
The Department of Transportation has reviewed the material submitted. We have no comments to offer nor do we have any objection to the project.
