At the prehearing conference, the Board will entertain arguments on (1) the issue of standing, based on the information in petitioner National Whistleblower Center's (NWC) August 7, 1998 hearing request/intervention petition and any additional information NWC supplies in conjunction with its petition supplement, now scheduled to be filed on or before October 1, 1998; and (2) the admissibility of any NWC contentions proffered in its petition supplement.


