Document Processing Center (DPC) Services

On July 24, 2014, as a result of a U.S. General Service Administration Federal Supply Schedule competitive acquisition, a Labor-Hour Delivery Order (GS35F0477Y/NRC-HQ-10-14-T-0001) was awarded to Logistic Systems Incorporated, located in Washington, DC. This contract will provide the necessary resources to perform document and information processing services for the NRC. The period of performance is August 5, 2014 through August 4, 2019, which includes one base year with four 1-year option periods. The total contract value is \$5,875,286.40, inclusive of all options. Through the competitive process, the agency saved over \$3,000,000.

FY 2014 Science, Technology, Engineering, and Math (STEM) Grant Awards

On August 1, 2014, the Resources and Grants Team awarded 47 new STEM awards to colleges, universities, and trade schools in the areas of Faculty Development, Fellowships, and Scholarships totaling \$14,982,000. The period of performances on these grant awards range from 2 to 4 years in length.

Technical Assistance in Support of Agency Environmental and Reactor Programs

On August 5, 2014, as a result of a competitive, multiple-holder indefinite delivery, indefinite quantity, three task orders were awarded as follows: 1) SC&A, Inc., (NRC-HQ-25-14-E-0003) in Vienna, VA; 2) Energy Research, Inc., (NRC-HQ-25-14-E-0002) in Rockville, MD; and 3) Numark Associates, Inc., (NRC-HQ-25-E-14-0001) in Washington, DC. These task orders will provide technical assistance in support of NRC Environmental and Reactor Programs. The period of performance is August 5, 2014 through August 4, 2019. The total contract value is \$150,000,000.

Summer 2014 Institute of Electrical and Electronics Engineers Nuclear Power Engineering Committee Meeting

From July 28 through 30, 2014, the staff participated in the summer 2014 Institute of Electrical and Electronics Engineers (IEEE), Nuclear Power Engineering Committee (NPEC) meeting in Minneapolis, Minnesota. In addition to attending the general NPEC meeting, the staff participated in various working groups under SC-3 (Operating, Maintenance, Aging, Testing, and Reliability) and SC- 4 (Auxiliary Power). The staff discussed recent NRC activities associated with each subcommittee. SC-4 members were specifically interested in offsite poweropen phase condition and staff actions related to onsite power systems.

Issuance of Sequoyah Draft Supplemental Environmental Impact Statement

On July 31, 2014, the staff issued for public comment the draft supplemental environmental impact statement (SEIS) on the proposed renewal of the operating license for Sequoyah Nuclear Plant, Units 1 and 2. The report contains the NRC's preliminary finding that there are no environmental impacts that would preclude the option of license renewal for an additional 20 years of operation. As part of its environmental review of the application, the NRC will hold public meetings on September 17, 2014, near the plant, to discuss the preliminary findings in the draft SEIS and to solicit public comments on the document. The public comment period ends September 29, 2014. This is the sixth license renewal environmental impact statement issued since the United States Court of Appeals for the District of Columbia Circuit vacated the Waste Confidence Decision rule. The staff continues to move forward with license renewal reviews; however, consistent with the direction provided by the Commission, the staff will not issue renewed licenses until the issues related to waste confidence are appropriately addressed.

Annual Nuclear Medical Resource Professionals User Group Conference

During the week of August 4, 2014, the staff participated in the annual Nuclear Medical Resource Professionals (NMRP) User Group Conference held in Clearwater, Florida. The purpose of the conference was to share recent experiences regarding medical issues for nuclear power plant personnel and to discuss the many benefits for licensees to commit to using the newly revised medical standard, ANSI/ANS-3.4-2013, "Medical Certification and Monitoring of Personnel Requiring Operator Licenses for Nuclear Power Plants." The conference was attended by staff from headquarters and all four regions.
