Hello,

I cannot believe that it is already August. I hope everyone has been enjoying their

summer. The KI has been ordered and is expected sometime in late August to early September. The tablets are made in Sweden and shipped to the US. The allotted time from order to receipt is usually about 90 days, and frequently less. However, because they are made outside of the USA, they need to clear not only US Customs but also clearance from the FDA inspectors. The tablets are then delivered in bulk to HHS for repackaging and final shipment. As soon as we have the expected dates for shipment to you we will let you know. If there have been any changes in the delivery information or if you need a specific date or time range for delivery please let us know ASAP so that we can ensure that your KI delivery proceeds as smoothly as possible.
