SITE AND NOTICE OF VIOLATION

Dear Mr. McClure:

On June 6, 2014, Robert L. Gallagher of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was limited to a review of security and control of licensed material. Additional information provided in the telephone conversation on August 12, 2014, between Terri Richards of your organization and Mr. Gallagher was also examined as part of the inspection. The findings of the inspection were discussed with Ms. Richards on August 12, 2014.

Based on the results of this inspection and in accordance with the NRC Enforcement Policy, the NRC has determined that one Severity Level IV violation of NRC requirements occurred. The violation involved the failure to secure from unauthorized removal or access licensed materials that are stored in a controlled area.

The violation is cited in the enclosed Notice of Violation (Notice), because the violation was identified by the NRC. During our inspection exit meeting on August 12, 2014, Ms. Richards indicated that you have taken corrective and preventative actions to address the violation and that Camden-Clark Memorial Hospital Corporation is committed to radiation safety and to compliance with NRC regulations and licensed conditions. Further, Ms. Richards stated verbally on August 12, 2014, that you have taken the following corrective and preventative actions:

- 1) Effective June 7, 2014, Camden-Clark Memorial Hospital Corporation instituted a policy requiring the door to the Hot Lab area to be closed and locked at all times; and
- 2) Access to the Hot Lab will be by electronic key card issued only to Nuclear Medicine Department staff that requires access to perform their duties.

The NRC has concluded that information regarding: (1) the reason for the violation; (2) the corrective actions that have been taken and the results achieved; and (3) the date when full compliance was achieved is already addressed on the docket in the Inspection Report No. 2014001. Therefore, you are not required to respond to this letter unless the description herein

does not accurately reflect your corrective actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.

NOTICE OF VIOLATION

Camden-Clark Memorial Hospital Corporation
Parkersburg, WV

During an NRC inspection conducted on June 6, 2014, one violation of NRC requirements was identified. In accordance with the NRC Enforcement Policy, the violation is listed below:

10 CFR 20.1802 requires, in part, that the licensee secure from unauthorized removal or access licensed materials that are stored in a controlled area.

Contrary to the above, on June 6, 2014, Camden-Clark Memorial Hospital Corporation did not secure from unauthorized removal or access licensed materials that were stored in a controlled area.

This is a Severity Level violation IV (Supplement 6.7.6).

The NRC has concluded that information regarding the reason for the violation, the corrective actions taken and planned to correct the violation and prevent recurrence and the date when full compliance will be achieved is already adequately addressed on the docket. However, you are required to submit a written statement or explanation pursuant to 10 CFR 2.201 if the description therein does not accurately reflect your corrective actions or your position. In that case, or if you choose to respond, clearly mark your response as a "Reply to a Notice of Violation," and send it to the U.S. Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington, D.C. 20555 with a copy to the Regional Administrator, Region I, within 30 days of the date of the letter transmitting this Notice of Violation (Notice).

If you contest this enforcement action, you should also provide a copy of your response to the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001. Under the authority of Section 182 of the Act, 42 U.S.C. 2232, any response which contests an enforcement action shall be submitted under oath or affirmation.

Your response will be placed in the NRC Public Document Room (PDR) and on the NRC Web site. To the extent possible, it should, therefore, not include any personal privacy, proprietary, or safeguards information so that it can be made publically available without redaction. However, if you find it necessary to include such information, you should clearly indicate the specific information that you desire not to be placed in the PDR, and provide the legal basis to support your request for withholding the information from the public.

In accordance with 10 CFR 19.11, you may be required to post this Notice within two working days of receipt.
