**Review of License Amendment Request for the Beaver Valley Power Station**

On August 12, 2014, as a result of a non-competitive solicitation, a cost-reimbursement type task order (NRC-HQ-20-14-T-0008) was awarded to Southwest Research Institute of San Antonio, TX. The contract will provide for the review of the license amendment request for the Beaver Valley Power Station, Units 1 and 2, transition to National Fire Protection Association Standard (NFPA 805). The period of performance is September 1, 2014, through May 31, 2016. The total estimated ceiling amount for the task order is \$182,970.
