John,

This is a follow-up to the emails from Dr. Longmire below regarding Prairie Island's July 31 response to RAIs for the ISFSI License Renewal Application --

Our July 31 response to the Second RAI needed to be re-submitted to meet the NRC's electronic submittal requirements. We had not received the August 4 email (see below) from Ms. Buan (the 24 Mb file was too big for our email system), and we learned of this from Dr. Longmire on Tuesday.

We re-processed the submittal file with higher resolution and re-submitted the subject letter via FedEx on 8/20 (tracking no. 8015 2416 6256, received 8/21). **Please note that there were no changes to any content in the submittal files - the informal CDs that we sent to you for use by the Staff reviewers remain unchanged.** The changes to the submittal merely provide higher resolution so that the files can be processed for ADAMS. As a backup, in case there are any issues with the electronic file, we also provided a hard copy of the letter in the FedEx package.

We believe that this re-submittal will allow the RAI response letter to be entered into ADAMS and into the hearing file. I will contact you next week after you return, but in the meantime, if you have any questions or further concerns, please contact me.
