**Enterprise-Wide Contract for Technical Assistance in Support of the U. S. Nuclear Regulatory Commission Environmental and Reactor Programs**

On August 19, 2014, as a result of a competitive solicitation, three multiple awards, indefinite-delivery/indefinite quantity Enterprise-Wide Contracts, were awarded to Numark Associates, Incorporated of Washington, DC; Energy Research, Inc., of Rockville, MD; and Information Systems Laboratories, Inc., of San Diego, CA. The contracts will provide technical assistance to U. S. Nuclear Regulatory Commission (NRC) staff in support of the NRC Environmental and Reactor Programs. The period of performance is August 19, 2014, through August 18, 2019. The total estimated cost ceiling is \$200,000,000, which is shared equally amongst the three awardees.

**Rulemaking and Guidance Development for Security Requirements Related to Physical Security for Nuclear Material and Nuclear Facilities**

On August 21, 2014, as a result of a non-competitive solicitation, Task Order NRC-HQ-11-14-T-0003 was issued under Enterprise Wide Agreement No. NRC-HQ-25-14-D-0004, to Oak Ridge National Laboratory, Oak Ridge, TN. The task order will provide technical and editorial expertise with the Part 73 security rulemaking activities, including updating and developing regulatory guidelines pertaining to physical security for nuclear material and nuclear facilities. The period of performance is September 1, 2014, through August 30, 2017. The total estimated cost ceiling is \$423,000.

**Issuance of Limerick Supplemental Safety Evaluation Report**

On August 12, 2014, the staff issued a supplemental safety evaluation report (SSER) for the Limerick Generating Station (LGS), Units 1 and 2, license renewal application. The SSER documents the staff's review of additional information provided by the applicant since the staff's issuance of the SER in January 2013. This information includes annual updates required by 10 CFR 54.21(b) and updated information and commitments in response to recent industry operating experience. The staff concluded that the additional information provided did not alter the conclusion proffered in the SER issued in January 2013.

**Issuance of Callaway Final Safety Evaluation Report**

On August 21, 2014, the staff issued the final Safety Evaluation Report (SER) related to the Callaway Nuclear Plant, Unit 1, license renewal application (LRA), which Union Electric Company, (doing business as Ameren Missouri), submitted to the U.S. Nuclear Regulatory Commission in December 2011. The final SER summarizes the results of the staff's safety review of the LRA in accordance with Title 10 of the Code of Federal Regulations, Part 54, "Requirements for Renewal of Operating Licenses for Nuclear Power Plants," and describes the technical details considered in evaluating the proposed operation of the plant for an additional 20 years beyond the term of the current operating license.
