SUBJECT: TRANSMITTAL OF SUMMARY REPORT REGARDING HISTORIC AND CULTURAL PROPERTIES FOR THE PROPOSED POWERTECH (USA), INC. DEWEY-BURDOCK IN-SITU URANIUM RECOVERY PROJECT

Dear Mr. Enemy:

With this letter, the U.S. Nuclear Regulatory Commission (NRC) is providing you with the "Summary Report Regarding the Tribal Cultural Surveys Completed for the Dewey-Burdock Uranium In-Situ Recovery Project" (Enclosure 1) for your review and comment.

Representatives of Native American Tribes with historical- and traditional-use ties to the Dewey-Burdock In-Situ Uranium Recovery (ISR) Project area conducted a field reconnaissance survey for properties of religious and cultural significance to Tribes (otherwise referred to as Traditional Cultural Properties (TCPs)) in 2013. The purpose of this field survey was for the Tribes to: (a) identify TCP resources within the 10,580-acre Dewey-Burdock Project area; (b) evaluate the TCPs for National Register of Historic Places (NRHP) eligibility; and (c) make recommendations for mitigation of the adverse effects of TCPs considered NRHP-eligible by the respective Tribes.

By letter dated February 8, 2013, the NRC offered each consulting Tribe the opportunity to participate in a field survey for the proposed Dewey-Burdock ISR facility. The field survey was conducted in two phases between April 2, 2013 and May 23, 2013, during which representatives from the Crow, Northern Cheyenne, Crow Creek Sioux, Northern Arapaho, Turtle Mountain Band of Chippewa Indians, Cheyenne and Arapaho Tribes of Oklahoma, and Santee Sioux Tribes participated.

The enclosed report (Enclosure 1) summarizes the combined findings of the respective Tribes and provides recommendations for NRHP eligibility and resource management of the TCP sites identified in the Dewey-Burdock Project area. Based on the Tribal recommendations, Enclosure 1 also includes the NRC's determinations of eligibility and assessments of effects on the TCP sites in accordance with 36 CFR 800.5. The NRC's overall determinations of eligibility and assessments of effects including TCP sites listed in Enclosure 1 and archeological sites previously made available for review and comment are documented in Enclosure 2 for your information.
