To Members of the Licensing Board Panel:

Powertech wishes to request clarification on what is required of the company within the three day period identified in yesterday's Order regarding OST Exhibit 019 and the disclosure of data identified in the exhibit. Powertech believes this response complies with the Board's request for a response within the three day period.

First, Powertech believes that the Board would benefit from legal argument from all parties regarding this issue which was not the purpose of the recent telephone conference regarding procedural matter. Powertech is in a position to offer such legal argument no later than close of business tomorrow, Friday the 8th of August. Additionally, if the Board would prefer oral argument on the issues, Powertech counsel is prepared to participate in such argument. Powertech believes that it can offer a colorable claim that this data is not relevant to Contention 3 and that there is no need for disclosure, especially considering that the Board rejected a request for cross-examination on the issues raised in OST Exhibit 019 based on the substance being outside the scope of the admitted contentions.

Second, Powertech believes that the Board should be briefed on what the substance of the acquired data is and how it is not relevant to the safety and environmental-related arguments offered by CI and the Tribe and the fact that Powertech does not have access to all of the data described in the press release and will not until sometime in September. Powertech is prepared to offer an affidavit with any legal argument demonstrating that the data is not relevant to understanding the stratigraphy aspects of the Project, is not within the scope of Contention 3, and is not completely within Powertech's possession. This is especially important because Powertech believes that other counsel's characterization of this data is incorrect. Further, CI and the Tribe have made no showing how such logs will assist them with Contention 3 and never previously asked for borehole logs that Powertech used to generate the isopach maps, structure contour maps, etc regarding site stratigraphy in its application materials. Powertech believes the Board should at least be informed of what the substance of the data is and how it relates to what was submitted in the Powertech's license application prior to requiring disclosure. In the event that disclosure is mandated, Powertech will require signatures from all parties receiving the data to the current Protective Order or another confidentiality agreement agreed upon by all parties. The data is being purchased with a financial premium due to its economic value and cannot be disclosed publicly.

Lastly, Powertech requests that the Board please clarify what, if any, changes to the hearing schedule or subsequent briefing that will occur in the event that the data is or is not disclosed prior to the hearing. Preparations already have been made for Powertech personnel and counsel to attend the hearing on the 18th of August and would respectfully request notification of any potential delays.
