By letter dated June 17, 2014, PriMed, LLC d/b/a Heart Specialists, PC of Southern Connecticut (NRC License No. 06-30657-01) and PriMed, LLC d/b/a Connecticut Heart & Vascular Center (NRC License No. 06-30537-01) submitted to the U.S. Nuclear Regulatory Commission (NRC) an amendment request for the two licenses to be merged on NRC Materials License No. 06-30657-01. The letter also requested Consent to direct License Transfer of activities, facilities, and equipment from the merged NRC Materials License No. 06-30657-01 to Northeast Medical Group, Inc. Based on the information you provided, we understand that as a result of a proposed sale of PriMed, LLC d/b/a Heart Specialists, PC of Southern Connecticut and PriMed, LLC d/b/a Connecticut Heart & Vascular Center to Northeast Medical Group, Inc., control of both PriMed, LLC facilities will directly be transferred to Northeast Medical Group, Inc. The existing facilities at Four Corporate Drive, Suite 100, Shelton, Connecticut and 112 Quarry Road, Suite 400, Trumbull, Connecticut, will be operated by Northeast Medical Group, Inc. under License No. 06-30657-01. We further understand that this transfer will not result in any change to licensed material, persons using the licensed material, or location of use of licensed material. Finally, we understand that the Radiation Safety Officer (RSO) from PriMed, LLC d/b/a Connecticut Heart & Vascular Center will serve as the RSO on the Northeast Medical Group, Inc. license and will continue to oversee the Radiation Safety Program in the facilities previously operated by PriMed, LLC.

Based on the above understandings and as more fully detailed in the enclosed NRC staff's Safety Evaluation Report which documents the NRC staff's review of the request, we have no objection to the proposed transfer. We understand that the sale took place on June 1, 2014. Enclosed with this letter is the amended license transferring the facilities and materials of PriMed, LLC d/b/a Connecticut Heart & Vascular Center under NRC License No. 06-30537-01 to the NRC License No. 06-30657-01 under the new owner Northeast Medical Group, Inc. This is being issued concurrent with the termination of the PriMed, LLC d/b/a Connecticut Heart & Vascular Center license under Mail Control Number 584199. In addition, please note that the tie-down documents from License No. 06-30537-01 that described facilities, equipment, and procedures have been included in the last condition of the enclosed license.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice for Domestic Licensing Proceedings and Issuance of Orders," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS). ADAMS is accessible from the NRC website at <http://www.nrc.gov/reading-rm/adams.html>.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
