CHANGE IN LICENSED OPERATOR LICENSE RESTRICTIONS

Gentlemen:

An updated Certification of Medical Examination by Facility Licensee (i.e., NRC Form 396) and the attending physician's Medical Statement are contained within Enclosure 2 for the licensed individual listed in Enclosure 1 to this letter.

The updated Form 396 is being submitted in accordance with 10 CFR 50.74 and 10 CFR 55.25 to reflect a change in the status regarding the licensed operator's medical examination required by 10 CFR 55.21. The licensee's routine medical evaluation determined that he is to be permanently restricted to the use of corrective lenses while performing licensed duties.

The revised NRC Form 396 (i.e., Enclosure 2) is being transmitted to the NRC Region II only.

Carolina Power & Light Company requests that the information in the Enclosures be withheld from public disclosure in accordance with 10 CFR 2.790(a)(6) since the disclosure of this information would constitute a clearly unwarranted invasion of personal privacy.


