NOTIFICATION OF CHANGE IN LICENSED OPERATOR LICENSE RESTRICTIONS

Gentlemen:

Carolina Power & Light (CP&L) Company submits the enclosed Certification of Medical Examination by Facility Licensee (i.e., NRC Form 396) and the examining physician's medical statement for a licensed Senior Reactor Operator at the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. The individual's name, license number, and docket number are provided in Enclosure 1 to this letter. The NRC Form 396 is being submitted in accordance with 10 CFR 55.25 and 10 CFR 50.74 to reflect a change in license restrictions for the referenced individual and is provided as Enclosure 2 to this letter. This notification is required to be submitted by November 6, 1996. The licensee's routine medical evaluation determined that he is to be permanently restricted to the use of corrective lenses while performing licensed duties. The NRC Form 396 is being transmitted to Region II only.

In accordance with 10 CFR 2.790(a)(6), we request that the information in the enclosures be withheld from public disclosure because the enclosures contain personnel and medical files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Accordingly, the enclosures are being transmitted directly to Mr. Thomas A. Peebles, Chief, Operations Branch, NRC Region II Division of Reactor Safety.
