REQUEST FOR REMOVAL OF LICENSE CONDITION

Sir or Madam:

The purpose of this letter is to request that the NRC remove license conditions imposed in accordance with 10 CFR 55.23(b). Enclosed is a Certification of Medical Examination by Facility Licensee (i.e., NRC Form 396) for two licensed Senior Reactor Operators at the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. The individuals' names, corrected addresses, license number, and docket numbers are provided in the attachment to this letter. The NRC Forms 396 are being submitted in accordance with 10 CFR 55.23 to reflect a change in license restrictions to "no restrictions" for the referenced individuals and are provided as an enclosure to this letter. The licensees' medical examinations have determined that they no longer require the use of corrective lenses while performing licensed duties.
