The following information is being supplied per Appendix G of NUREG 1556, Vol. 9, Rev. 2. Hartford Hospital is in support of the transfer of control of its site at 11 South Rd., Suite 100, Farmington, CT. Such transfer will take place upon the State of CT, Office of Health Care Access' approval of Hartford Hospital's request to cease nuclear cardiac imaging at the Farmington site. The date of OHCA's final determination is unknown but expected before March 31, 2015.

1. Upon the State of CT approval to cease operations there, Hartford Hospital wishes to transfer control of all licensed activities and radioactive sources located at 11 South Road, Suite 100, Farmington CT, 06032 to Molecular Imaging Services, Inc. as an additional location of use on License No. 07-30790-01.
2. This transaction is a simple transfer of control. Molecular Imaging Services, Inc. is only purchasing the imaging and related hot lab equipment. Melissa Ferraro-Borgida, M.D., FACC and Brett H. Duncan, M.D., FACC will serve as Authorized Users and provide medical oversight at this location. Molecular Imaging Services, Inc. will provide radiation safety and technical oversight of the nuclear medicine technologists at this location. Frank DiGregorio (302-750-3668) will continue to serve as Radiation Safety Officer for Molecular Imaging Services, Inc., and should be contacted if more information is needed.
3. There will be no change in the organization, location, facility, equipment or procedures that relate to the licensed program.
4. The current surveillance program (surveys, wipe tests, QC, etc.) is ongoing and will not be interrupted by the transfer of control.
5. There are no plans for a formal decommissioning of the facility as the same equipment currently onsite, and personnel, will continue to be used in the same location by the transferee as was used by the transferor.
6. The transferee will abide by all constraints, conditions, requirements, and commitments of the transferor.
7. Melissa Ferraro-Borgida, M.D., FACC and Brett H. Duncan, M.D., FACC, will become Authorized Users on License No. 07-30790-01 for 35.100 and 35.200 uses. They were previously listed as an Authorized user under License number 06-00253-04. A copy is attached.
8. Molecular Imaging Services, Inc. is not the lessor of the space at the facility. A landlord waiver has been obtained and is attached to this request.



LandLord/Owner Consent to entry for the removal of Radioactive Material
