SUBJECT: FEDERAL REGISTER NOTIFICATION OF THE AVAILABILITY OF THE
COMBINED LICENSE APPLICATION FOR SOUTH TEXAS PROJECT UNITS 3
AND 4 IN ACCORDANCE WITH 10 CFR 50.43(a)(3) REQUIREMENTS

Dear Mr. Head:

On September 20, 2007, South Texas Project Nuclear Operating Company (STPNOC) submitted to the U.S. Nuclear Regulatory Commission (NRC), a combined license (COL) application to construct and operate two additional units (Units 3 and 4) at the South Texas Project Electric Generating Station site located in Matagorda County near Bay City, Texas. On January 24, 2011, Nuclear Innovation North America LLC (NINA) became the lead applicant for the licenses for these two units. The application is currently under review by the NRC staff.

In that September 20, 2007, application, STPNOC stated that it was submitting the COL application pursuant to the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, "Licenses, Certifications, and Approvals for Nuclear Power Plants," Subpart C, "Combined Licenses," and requested the associated materials licenses under 10 CFR Parts 30, 40, and 70. In addition, STPNOC stated that the COL application incorporates by reference the U.S. Advanced Boiling Water Reactor design certification in 10 CFR Part 52, Appendix A.

In accordance with the requirements found in 10 CFR 50.43(a)(3), the NRC staff intends to publish notice of the application for 4 consecutive weeks in the Federal Register. Enclosed is the notice that will be forwarded to the Office of the Federal Register to inform the public of the availability of the subject application.
