NOTIFICATION OF SIGNIFICANT ENFORCEMENT ACTION

Subject: ORDER IMPOSING CIVIL PENALTY - \$3,500

On November 19, 2014, the NRC issued a Notice of Violation and Proposed Imposition of Civil Penalty (Notice) in the amount of \$3,500 to ATC Group Services, Inc., for a Severity Level III violation. The violation involved the failure to control and maintain constant surveillance of licensed material that was in an unrestricted area and not in storage as required by 10 CFR 20.1802. Specifically, on November 18, 2013, a licensee employee left a portable gauge secured in the back of an open-bed truck with the vehicle doors unlocked and keys in the ignition. The vehicle was subsequently stolen, and the gauge has not been recovered.

The licensee responded to the Notice and did not deny the facts surrounding the violation. However, the licensee disagreed with the NRC's assessment of the safety significance of the violation and requested that the violation be deemed a Severity Level IV violation. The staff reviewed the licensee's response and the staff's application of the factors described in Section 2.2, "Assessment of Violations," of the NRC Enforcement Policy and determined that an adequate basis did not exist for either a reduction of the severity level or mitigation of the civil penalty. Consequently, the proposed civil penalty in the amount of \$3,500 should be imposed.

Accordingly, an Order Imposing Civil Penalty in the amount of \$3,500 will be issued on or about March 26, 2015. Under the terms of the Order, the licensee may, within 30 days of the date of the Order, pay the civil penalty or request a hearing
