SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON MARCH 19, 2015

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on March 19, 2015. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP), Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3.

Summary of Meeting:

On March 19, 2015, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP, Units 3 and 4, and SCE&G's VCSNS, Units 2 and 3. Specifically, the meeting discussed SCE&G's request letter for a Commission-Approved Simulation Facility for VCSNS, Units 2 and 3 and a list of Draft RAIs about SCE&G's request letter.

The NRC staff and SCE&G reviewed the Draft RAI questions in order to come to a common understanding of the additional information that the licensee needed to provide in their request letter for a Commission-Approved Simulation Facility. A number of the Draft RAI questions were discussed in the closed portion of the meeting due to their security-related or proprietary nature. SCE&G stated that they understood the staff's Draft RAIs and comments and agreed to supplement their request letter based on their understanding of the additional information needed. The staff noted that a future audit will be needed to verify the summary information provided in the supplement.

At the end of the open portion of the meeting, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the open portion of the meeting.
