On March 20, 2015 the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Oyster Creek Nuclear Generating Station. On March 25, 2015, the NRC inspectors discussed results of this inspection with Mr. Timothy Keenan and other members of your staff. Inspectors documented the results of this inspection in the enclosed inspection report.

The NRC inspectors did not identify any findings or violations of more than minor significance.
