**SUBJECT: REQUEST FOR ADDITIONAL INFORMATION**

Dear Mr. Hatcher:

This letter refers to your application dated January 20, 2015, for a U.S. Nuclear Regulatory Commission (NRC) exempt-distribution license and for a Sealed Source and Device Registration (Agencywide Documents Access and Management System (ADAMS) No. ML15028A009 and No. ML15029A415, respectively).

We do not have sufficient information to complete the review of your application. In the enclosure to this letter, we have summarized the issues that need to be addressed.

Please be aware that you may request that certain portions of your submittal to the NRC be withheld from public disclosure as proprietary information. To do this, you must execute an affidavit as specified in 10 CFR 2.390. You must list all portions that you wish to be held proprietary, along with your reasoning as to why that is appropriate. While it is allowable, please refrain from submitting proprietary information in support of a license unless necessary. Keep in mind that all NRC licenses are considered to be in the public domain, and therefore, may be viewed by any member of the public who requests to see them.

We will continue our review upon receipt of this information. If we do not receive your reply within 30 calendar days from the date of this letter, we will consider your application as having been abandoned by you. This action would be without prejudice to the resubmission of another application with the required information.

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's Agencywide Documents Access and Management System (ADAMS).
