The purpose of this letter is to provide a status of the Watts Bar Nuclear Plant (WBN) Unit 2 Cyber Security Plan (CSP) Implementation Milestones 1 – 7 and a proposed WBN Unit 2 CSP License Condition.

Enclosure 1 contains the status of completion of CSP Implementation Milestones 1 through 7 for WBN Unit 2. Enclosure 2 provides a proposed WBN Unit 2 Facility Operating License Condition to be included with the Facility Operating License when issued by the NRC. TVA is providing this proposed License Condition to coordinate with a WBN Unit 1 submittal dated April 1, 2015, (TVA Letter No. CNL-15-021) that clarifies the Bright-Line demarcation point between assets controlled by the Nuclear Power Group and those controlled by the Transmission and Power Operation group.

TVA is submitting this information to support a proposed NRC inspection to assess and verify that the licensee's cyber security program interim implementation milestones one through seven have been implemented in accordance with the regulatory requirements of 10 CFR 73.54, NRC approved CSPs and implementation schedules.

TVA considers Enclosure 1 to contain security related information and requests it be withheld from public disclosure pursuant to 10 CFR 2.390(d)(1).


