To Whom It May Concern:

This request is being made pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. 522, as amended, for documents regarding the Palisades Nuclear Plant, operated by Energy Nuclear Operations, Inc. The term "documents" is meant to include: any and all Agency records and information, including letters, notices, memoranda, emails, inspection reports, confirmatory orders; and any and all information received from Entergy, regarding or relating in any way to:

**Office of Investigations Inspection Report No. 3-2013-018, the July 21, 2014 Confirmatory Order EA-14-013, and any and all information or documentation provided to the NRC by Entergy Nuclear Operations, Inc. that reflects any Entergy actions taken to reward or positively acknowledge the security personnel (Security officers and/or supervisors) who challenged the Entergy Management decisions at issue in the OI Report, and/or who brought the matter to the attention of the NRC. This should also include any documents reflecting the commitments Entergy made as a result of the Confirmatory Order, and any follow-up reporting of commitments that were met.**

This request includes all agency records as defined in the Code of Federal Regulations and the agency manual, whether they currently exist in the official "working" investigative or other files, or at any other location, including private residences.

If any records covered by this request have been deleted, destroyed and/or removed after this request, please provide all surrounding records, including but not limited to a list of all records

which have been or are deleted, destroyed and/or removed, a description of the action(s) taken, and those relevant to or generated in connection with implementing the action(s).


