Parkland Health Center, accepts full liability for the site. No decommissioning is required.





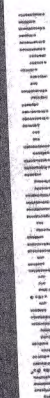
