Dear Ms. Johnson:

By letter dated January 26, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15084A309, LES-15-00015-NRC) [Official Use Only information - not publicly available], as required by Title 10 of the *Code of Federal Regulations* (10 CFR) 70.32(e), Louisiana Energy Services, LLC (LES or the licensee) submitted its non-substantive changes to the U.S. Nuclear Regulatory Commission (NRC) regarding URENCO USA's (UUSA's) Physical Security Plan (PSP), Revision 11, dated December 19, 2014.

On March 25, 2015, a conference phone call was held between NRC and UUSA personnel to discuss a typographical error identified during the NRC staff's review (ADAMS Accession No. ML15085A086) [Official Use Only information - not publicly available]. As a result, by letter dated March 27, 2015 (ADAMS Accession No. ML15098A020, LES-15-00062-NRC) [Official Use Only information - not publicly available], LES submitted Revision 11a to its PSP which replaced Revision 11 for the UUSA facility. The staff noted that Revision 11a of the PSP provided an editorial change to correct the typographical error contained in Revision 11 and added the document revision number to page footers.

The staff has reviewed the UUSA PSP, Revision 11 and Revision 11a provided by LES and found the changes acceptable. Enclosed is the staff's Safety Evaluation Report which contains sensitive security information.

The LES PSP, Revision 11, as replaced by Revision 11a, contains sensitive security information and therefore, in accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," and will not be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's ADAMS.
