REVIEW OF LAGOON SAMPLING METHODOLOGY


The purpose of this letter is to submit the Final Status Surveys (FSS) including dose modeling using NRC approved software for portions of MU's Sinclair Farm properties. We request a technical review by the NRC region III decommissioning branch to determine if survey methodologies used for two lagoons are acceptable because the MARSSIM survey protocols and default screening values are only applicable to surface soils.

MU previously requested NRC review of these FSS (along with other decommissioning items) during an in-person meeting with Mr. Lafranzo, Dr. Lee, and Mr. Strohmeyer during the NRC site visit at MU's campus on Feb 10, 2015. It was concluded that MU should send the FSS's of the impacted areas Sinclair Farm for the NRC's review to determine if any additional actions or surveys on the farm are necessary.

MU would like NRC concurrence to proceed with unrestricted release of the Sinclair Farm properties impacted by historical licensed activities.


