**SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR PEACH BOTTOM ATOMIC POWER STATION, UNIT NO. 2
(TAC NO. MF4792)**

Dear Mr. Hanson:

By letter to the Nuclear Regulatory Commission (NRC) dated April 5, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML15096A008), Exelon Generation Company, LLC (Exelon) submitted a Westinghouse Electric Company LLC (Westinghouse) affidavit dated April 2, 2015, executed by Mr. James A. Gresham (Attachment 3 to Exelon's letter). Exelon requested that the information contained in Attachment 1 to its letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390. Specifically, Exelon requested that the following document be withheld:

LTR-BWR-ENG-15-032-P, "Response to the U.S. NRC Requests for Additional Information Relative to the Peach Bottom Replacement Steam Dryer Acoustic/Structural Analyses Set"

A non-proprietary copy of the document (Attachment 2 to Exelon's letter) has been placed in the NRC's Public Document Room and added to the Agencywide Documents Access and Management System Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)(ii)(a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
- (4)(ii)(c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.
