The State of CT has granted Hartford Hospital permission to terminate services at our off-site, outpatient cardiac imaging centers. We wish to relinquish control of the 100 Simsbury Road, Suite 202, Avon, CT nuclear cardiac imaging site to Consulting Cardiologists, PC. This transaction is a simple transfer of control.

Consulting Cardiologists, PC, is licensed to operate a nuclear cardiac imaging, outpatient center at 305 Western Blvd, Glastonbury, CT. Hartford Hospital's Avon site will transfer to and become Consulting Cardiologists' second location of radioactive material use on their specific license. There will be no change in the radiation safety program or procedures currently in effect for Consulting Cardiologists, PC, other than the inclusion of the Avon site into their radiation safety program.


1. The current surveillance program (surveys, wipe tests, QC) is ongoing and will not be interrupted by the transfer of control.
2. There are no plans for a formal decommissioning of the facility as the same equipment and the sources currently onsite will continue to be used in the same location. An exception to this is: the two Gd-153 line source and holder assemblies for patient attenuation correction will be removed from the gamma camera at the site and returned to Hartford Hospital for disposal.


