Pursuant to Title 10, Code of Federal Regulations, Part 50, Section 90 (10 CFR 50.90), Duke Energy proposes to amend Appendix A, Technical Specifications, for Facility Operating Licenses DPR-38, DPR-47 and DPR-55 for Oconee Nuclear Station, Units 1, 2, and 3. The proposed change revises the number of required channels for the RCS Hot Leg Temperature Function.

The revised Technical Specification pages are included in Attachment 1. Attachment 2 contains the markup of the current Technical Specification pages. The Technical Justification for the amendment request is included in Attachment 3. Attachments 4 and 5 contain the No Significant Hazards Consideration Evaluation and the Environmental Impact Analysis, respectively.

This proposed change to the Technical Specifications has been reviewed and approved by the Plant Operations Review Committee and Nuclear Safety Review Board. Implementation of these changes will not result in an undue risk to the health and safety of the public. In addition, the Oconee Updated Final Safety Analysis Report has been reviewed and no changes are necessary to support this amendment request.
