Please find attached revisions to the Technical Specification Bases for 3.1.1 Shutdown Margin which was revised to reflect the minimum RCS temperature from 70 F to 60 F consistent with TS Amendment 302. Further on May 11, 1999, TS Bases 3.4.12, LTOP was revised to implement LTOP settings and limits to be consistent with TS Amendment 302. The changes to TS Bases 3.4.12 include relocation of certain LTOP requirements from Selected Licensee Commitments to the Bases LCO section in response to an NRC request.
