By letter dated October 28, 1997, Duke Energy submitted an amendment request to convert to Improved Technical Specifications. By letters dated March 26, 1998, and May 20, 1998, Duke Energy submitted Supplements 1 and 1A to the ITS submittal. This Supplement further revises the submittal to:

1. Incorporate changes to the current Technical Specifications which have been approved by the Staff since the original submittal date,
2. Correct minor errors, identified by Duke Energy, which were found after the submittal. The majority of these self-identified changes are to correct typographical errors or to maintain consistency between the various sections of the submittal,
3. Incorporate changes which have resulted from discussions between Duke Energy and the Staff in relation to ITS sections 3.1, 3.2, 3.3, 3.4, 3.5, 3.7, 3.9, and 5.0.
4. Add a new Specification for Control Area Cooling (ITS 3.7.16), and
5. Remove TSC 95-04, Penetration Room Ventilation System Technical Specification Change, which has been withdrawn.


